



CAMP POLICIES SUMMER 2022

- 1) To be eligible for member rates, you must have an annual JCC membership. Annual JCC membership must be valid at the time of registration **and** extend through the camper's last 2022 camp day.
- 2) All camp fees must be paid by May 1, 2022. Camp Wise reserves the right to cancel registrations with unpaid balances.
- 3) For all registrations prior to November 1, 2021, a minimum payment of \$500 per camper per enrolled session is due on November 1, 2021. For registrations submitted after November 1, 2021 a minimum payment of \$500 per camper per enrolled session is due at the time of registration.
- 4) Prior to March 1, 2022, all camp fees are refundable for any reason. From March 1, 2022 – April 1, 2022 fees are refundable less a \$500 processing charge. After April 1, 2022, all fees are non-refundable and non-transferable.
- 5) For campers enrolled in a 7-week session: Prior to March 1, 2022, all camp fees for a dropped session are refundable. From March 1, 2022 – April 1, 2022, fees for a dropped session are refundable, but we will retain \$500. If both sessions are dropped, we will retain \$1,000. After April 1, 2022, all fees for one or both dropped session are non-refundable and non-transferable.
- 6) Financial Aid application requests must be submitted at the time of registration. For all registrations prior to November 1, 2021, a minimum payment of \$100 per camper per enrolled session is due on November 1, 2021. For registrations submitted after November 1, 2021 a minimum payment of \$100 per camper per enrolled session is due at the time of registration.
- 7) Participants in our ILS and SIT programs are not eligible for discounts including but not limited to: Sibling and Early Bird.
- 8) Any registrations with payment of at least \$500, between November 1, 2021 and November 30, 2021, will receive an Early Bird Discount of \$150. (The SIT and ILS programs do not qualify for this discount.)

- 9) Families enrolling more than one child will receive a sibling discount for each additional child of \$350. (The SIT and ILS programs do not qualify for this discount.)
- 10) There are no deductions for a camper arriving late or leaving early. Any requests for arriving or departing on dates other than the designated start and end date of sessions must be submitted to the camp office for approval prior to the start of the session by the Camp Wise Director.
- 11) The Camp Director reserves the right to dismiss any camper without refund who: willfully disregards camp rules or endangers the safety of themselves or others, physically, psychologically, or verbally abuses another member of the camp community, destroys camp property or the property of another member of the camp community, requires greater supervision than can reasonably be provided by camp staff, and/or possesses or consumes alcohol or illegal drugs while at camp.
- 12) Any camper who sustains an injury or illness while at camp, necessitating departure for the balance of the session, will have pro-rated fees refunded.
- 13) Refund requests after April 1, 2022 due to cancellation as a result of COVID-19, will be assessed on a case-by-case basis.
- 14) Prior to a camper's arrival, Camp Wise requires full disclosure of all medical and psychological treatments (past and present), a complete medical form signed by a physician, as well as immunization records.
- 15) The Camp Director and the medical staff are authorized to act on the behalf of a parent or guardian, according to their best judgment.
- 16) Camp Wise is not responsible for loss or damage to camper's property.
- 17) Camp Wise is authorized to take campers out of camp on supervised trips and activities.
- 18) Camp Wise may use any photo, slide, video recording, audio recording, or likeness of campers for promotional purposes.
